Financial Report

Transportation: Non-public of \$5,950 from North Kossuth for reimbursement from students in that district for transportation. Still waiting on West Bend-Mallard.

Balance Sheet-General Fund is negative \$10,000 plus because have not received Monsignor Lafferty and money from 4 year old preschool. If we know account will be in the negative for a length of time, GALA money will be transferred over.

Hot Lunch has a good balance

Bishop Garrigan Clearing negative balance has been cleared up.

Scrip account is good.

General Budget – As of Sept 2 a negative \$10,819, but Lynn Miller looked a week ago a positive balance. Parish payments on time, GALA and endowments are good. Expenditure/income are at 16.6%

Instructional expenditure is \$67,000. It is a higher percentage at the beginning of the school year. It will lower the end of the year.

Lynn Miller reported on a letter from the IAHSAA that only 207 schools in Iowa received, and Garrigan was one of those schools, that no students or coaches got ejected from a game.

Fundraiser

Seton and Garrigan will be doing a new fundraiser this year. The goal is to raise \$10,000 with a walk 'n prayer. Each student will sponsor \$50 and t shirts will be sponsored by farmers.
